In making these acknowledgments, I/we agree not to apply for or accept any payment for the relocation of our home or for abandoning my/our home from the Florida Mobile Home Relocation Corporation as long as I/we are parties or participants in such lawsuit or litigation against my/our park owner or in the event my/our park owner provides compensation for relocating or abandoning my/our mobile home.

In the event that I/we join in any lawsuit or litigation directly relating to or arising out of the change in use of the mobile home park pursuant to Chapter 723, Florida Statutes against my/our park owner, I/we agree to immediately repay any amount previously received for the relocation or abandonment of my/our home to the Florida Mobile Home Relocation Corporation within 30 days of my/our joining any such legal action. I/we are signing this acknowledgment freely and voluntarily and have sought the advice of an attorney if that is my/our desire.
